TERMS & CONDITIONS :-

- (1) The intending tenderers will have to submit their tender inscribing the words “Tender for obsolete vehicle” on the top of the cover and have to drop their tender at the drop box placed in the department.
- (2) The tenderers shall have to submit EMD of Rs 2000/- (Rupees two thousand) only for each vehicle and Rs.2,000.00 (Rupees two thousand) only for tyres as earnest money in the form of crossed Demand Draft / Bankers’ Cheque drawn in favour of Joint Secretary, General Administration (Sectt. Vehicle Cell) Department, from any Nationalised Bank which is payable at Guwahati.
- (3) The intending tenderers may inspect the vehicles during office hours on any working day from 11:30 A.M. to 2:30 P.M.
- (4) The successful tenderers will have to lift the vehicle on payment of the full amount / tender value within 3 (three) days from the date of issue of acceptance letter of this tender, failing which the offer will be treated as cancelled and earnest money will be forfeited.
- (5) The earnest money of the unsuccessful tenderers will be refunded.
- (6) The undersigned does not bind himself to accept the highest tender or to assign any reason for acceptance or rejection of any tender.


