ORDER

Subject to discharge without any notice and without assigning any reason thereof following **Bungalow Peons** are hereby temporarily appointed as MTS in the Assam Secretariat in the scale of Pay Rs.12000-37500(Pay Band-I) with Grade Pay of Rs. 3900/- P.M. plus other allowances as admissible from time to time with effect from the date of their joining in the post, as per decision in Hon'ble Cabinet held on 12.07.2023 and in exercise of power conferred by Rule 15 of the Assam Secretariat Grade-IV and Record Suppliers Service Rules, 1963.

Their services will be governed by the "New Define Contributory Pension Scheme, 2009" issued vide Finance Deptt.'s O.M. No.BW.7/2008/Pt/40 dated 06/10/2009.

If he/she accepts the appointment, then he/she should report for duty in General Administration (Sectt. Nazarat) Department within 15 (fifteen) days from the date of receipt of this order, failing which the appointment will stand cancelled.

The appointment is subject to producing of signed undertaking along with Notarized affidavit enclosed in **Annexure I & Annexure II** respectively at the time of joining. He/she should also produce all necessary certificates in original for verification at the time of joining, without which he/she will not be allowed to join.

Initially, the services of the temporarily appointed MTS will be placed with the Hon'ble Minister/Officer with whom he/she was engaged previously as Bungalow Peon till 31st March, 2024,(except those officers who have retired after 31-05-2023). Such MTSs will join in the General Administration (Sectt. Nazarat) Deptt.. Moreover confirmation of their service will be based on the performance certificate furnished every month up to 31.03.2024 by concerned Hon'ble Minister/Officer with whom their services are placed. This Deptt will have full discretion to terminate any such new appointee upon receiving of non-satisfactory report against him/her from the concerned Hon'ble Minister/Officer with whom his/her services will be placed until confirmation.
