Details Terms and Conditions

- 1. The intending tenderer should have their own registered Firm or registration of sole proprietorship. Provisional Registration certificate and firm registered after submission of tender will not be accepted.
- 2. The applicant shall have experience minimum of three years in relevant field.
- 3. The tenders should be submitted in 2(two) separate envelopes one containing only the relevant documents including earnest money deposit (Technical Bid), the other containing the financial implications (Financial Bid)
- 4. An amount of Rs. 10,000/- (Rupees ten thousand) only as earnest money in the form of NSC/Demand draft to be pledged in favour of Secretary to the Govt. of Assam, General Administration (Sectt. Nazarat) Department, should be submitted with the tender.
- 5. The Tender should be accompanied with all relevant and requisite documents.
- 6. The rate of each item of the menu should be quoted in the manner as indicated below:

a) Original rate.

- b) Rate and amount of GST should be quoted separately.
- 7. The rates quoted should be in Indian Rupees (INR) and should be written both in figures and words legibly.
- 8. The rates, once approved and accepted will remain valid upto the end of the contract period and will not be changed under any circumstances during the period as specified.
- 9. The selection procedure shall be based on the (a) lowest rates offered on maximum number of items. (b)lowest aggregate average of all items.
- 10. The successful bidders should maintain hygiene, cleanliness and catering service should be of acceptable standard.
- 11. The items supplied should be of standard quality.
- 12. Wastage should be placed in appropriate place fixed for disposal, at their own responsibility.
- 13. The firm will be responsible for all health hazards occurring to persons on consuming their eatables.
- 14. Waiters/Operators, in uniform, for the assigned work has to be provided by the firm itself..
- 15. The bidder is liable to comply with all Government legislation's such as rules regarding sales Tax, adulteration etc. He will be solely responsible for any non-compliance of Government guidelines/regulation.
- 16. The contract is for two years from the date of awarding the contract and which can be terminated earlier on account of the following:
 - a) Terminated by GAD on short notice due to unsatisfactory performance of the successful
 - b) In the event of breach of terms and conditions the allotment is liable to be canceled with one months notice.
- 17. The allottee has to execute and sign a deed of agreement on twenty Rupee stamp paper as per the format of GAD.
- 18.An amount of Rs.40,000/- per annum per kiosk only shall have to be paid by the successful bidder.
- 19. Successful bidders shall also install POS machine for digital transaction.
- 20.All disputes shall be subject to the jurisdiction of the Gauhati High Court, Assam.
