- 2. The tender documents should give the full information about the firm including address in full and contact Numbers.
- 3. The selected firm will have to supply the Acrylic Name Plates within 3(Three) days from the date of receipt of the supply order.
- 4. The Firm will have to provide only the best quality product and in no circumstances the General Admn.(Sectt.Nazarat) Department will compromise with quality.
- 5. The rates quoted in the Financial Bid should be both in figure and in words. GST should be clearly stated whether inclusive or exclusive and there should not be any over writing as far as possible.
- 6. The contract will be for a period of 2(Two) years i.e. with effect from the date of signing of the agreement.
- 7. The contract may be terminated before its expiry if the Govt. feels necessary. The contract is terminable by one months notice from General Administration Department's end.
- 8. The General Administration Department will be at liberty to advertise for a fresh tender on expiry of the existing contract or renew the same by a separate written order, subject to satisfactory performance of the firm.
- 9. The selected contractor will have to sign a contract agreement with the authority of General Administration Department, which will include all the terms & conditions mentioned herewith. Additional conditions may be added during the process of selection and included in the agreement, to be signed by the selected party.
- 10. The firm should be capable of supplying in the intended items at short notice.
- 11. All disputes shall be subject to the jurisdiction of the Gauhati High Court, Assam.
