NOTIFICATION

The 25th August, 1999

No. ABP.141/97/229.-- In exercise of powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Assam is pleased to make the following rules further to amend the Assam Ministerial District Establishment Service Rules, 1967, here-in-after referred to as principal Rules, in the manner here-in-after appearing, nemely :-

- Short title and commencement. 1. (1) This rules may be called the Assam Ministerial District Establishment Service (Amendment) Rules, 1999.
- (2) They shall come into force on the date of their publication in the Official Gazette.
- Amendment of rule 2. 2. In the principal Rules, in rule, 2 -
- (i) for the existing clause (1), the following shall be substituted, namely :-
- "(1) 'Appointing Authority' means, -
- (a) the Secretary to the Government of Assam, General Administration Department, in the case of appointment to the post of Revenue Sheristader,
- (b) the Commissioner of the respective Division, in the case of appointment to the posts of Sadar Head Assistants and Sub-Divisional Head Assistants, and
- (c) the concerned Deputy Commissioner in the case of appointment to all other Ministerial posts in the Deputy Commissioner and District Establishment."
- (ii) after clause (11), the following new clause shall be inserted, namely :-
- "(12) 'Governor' means the Governor of Assam."
- Amendment of rule 4. 3. In the principal Rules for the existing rule 4, the following shall be substituted, namely :-
- "4. status of service :- The status of the Revenue Sheristadar shall be that of Class-II Gazetted Ministerial Service and that of other staff shall be Class-III non-Gazetted Ministerial Service."
- Amendment of rule 6. 4. In the principal Rules, in rule 6, -
- (1) in sub-rule (1), before the caption word "Sheristader", the word "Revenue" shall be inserted.
- (2) below the note under clause (b) of sub-rule 6, the following new sub-rule shall be inserted namely :-

"(7) (i) For the purpose of selection, there shall be a Selection Board consisting the following members :-

(a) Secretary to the Government of Assam,
General Administration Department
..... Chairman.

(b) Commissioner of the concerned Division
..... Member

(c) *D.C. of the concerned dist. - Member.*

(d) Deputy Secretary to the Govt. of Assam,
General Administration (B) Department
..... Member-Secretary.

(ii) The Appointing Authority shall advertise the vacancies inviting application from suitable persons fulfilling the requirements of the post. The Appointing Authority concerned shall obtain the Annual Confidential Reports for last five consecutive years and relevant service particulars of eligible persons for recruitment to the cadre of Revenue Sheristadar and shall furnish to the Selection Board the Annual Confidential Reports and other relevant service particulars of the eligible persons alongwith the approximate number of vacancies likely to occur during the year. The Board shall examine the Annual Confidential Reports and relevant service particulars of the persons taking into consideration of the merit of the persons and prepare a list of names in order of preference for recruitment to the post.

The list shall be forwarded by the selection Board to the Appointing Authority.

(iii) The lists finally approved by the Appointing Authority shall be the select list for the purpose of appointment of Revenue Sheristadar.

(iv) The select lists shall remain valid for 12 calendar months from the date of approval by the Appointing Authority."

- (3) In the 'Note' below sub-rule (2) of rule 6, the word "Sheristadar" appearing in the first line of the paragraph shall be deleted and the following paragraph shall be inserted below the first paragraph of the 'Note' :-

"The Select list finalised and approved by the Commissioner of Division concerned for appointment to the post of Sadar Head Assistant and Sub-Divisional Head Assistant in the establishment of the Deputy Commissioner of the District concerned in the Division shall remain valid for 12 calendar months from date of its approval by the Commissioner of Division concerned."
