The Review Meeting of Aadhaar Enrolment Exercise in the State of Assam was presided over by Kumar Sanjay Krishna, IAS, Chief Secretary, Assam in presence of Shri P. Kumar, IAS, CEO, UIDAI. The members/representatives of State Aadhaar Implementation Committee also attended the meeting.

At the outset, Dr. M. Angamuthu, IAS, the Commissioner & Secretary to the Govt. of Assam, General Administration Department, welcomed all the officers and explained about the objectives of the meeting. Shri Devajit Khound, IES, Deputy Director General, UIDAI, Assam, gave a presentation on Aadhaar Enrolment related issues in the State.

After threadbare discussion on the performance of Registers like General Administration Department, other enrolment agencies like Banks, Post Offices, BSNL Offices and on assessment of present enrolment status in the State, following decisions were taken:

- Additional deployment of machines and manpower in the district to the tune of at least 1000 plus, considering the requirement and population in the respective districts.
- Deputy Commissioners to submit the requirement of additional men and machines required to be set up in the districts by 15th March, 2020.
- Deputy Commissioners to have a District Coordination Committee meeting by involving the DSWO,
 DEEO, Labor Officers, Joint Director of Health Services in the district to identify the requirement of setting up of enrolment centres in their respective district including tea garden areas.
- DCs to fix a 75 per cent target for completion of the enrolment exercise in the districts within this a year.
- IEC activities on Aadhaar enrolment exercise to be carried out from 1st April, 2020 in the district as well as at state level for public awareness.

The meeting ended with vote of thanks from the chair.
