- There is budget provision under the proper Head of Account and availability of vacant sanctioned posts with up-to-date retention.
- 2. The posts exist and have been duly created /retained and have not been abolished / kept in abeyance.
- Further, the posts will be filled up in compliance with the AFRBM Act, 2005, the Employment Exchanges (Compulsory Notification of Vacancies) Act, all reservation Acts (Reservation for SCs, STs, OBCs/MOBCs, Persons with Disabilities and Women) and all other relevant Rules/Procedures/Formalities as well as directions of the Hon'ble Supreme Court and also orders of the Hon'ble Gauhati High Court in the relevant cases.

 for Compassionate Appointment and approved herein as per the recommendation of the State
 Level Committee.

- 7. All appointments will be made after receipt of police verification report and medical fitness certificate as per procedure.
- 8. Before issue of appointment letter the Department will obtain undertaking from these selected candidates that they will abide by the New Pension Rules of the Government. This stipulation will be specifically mentioned in the appointment letter as already advised / ordered vide Finance (Budget) Department's letter No. BW.3/2003/Pt-I/1 dated 25-01-2001 for issue of instructions to the concerned treasuries for release of salaries intimating the names / lists of appointments.
- 9. This approval will remain valid up to 31-03-2019.
