**TERMS & CONDITIONS :-**

- (1) The intending tenderers will have to submit their tender inscribing the words "Tender for obsolete vehicle" on the top of the cover.
- (2) The tenderers shall have to submit EMD of Rs 1000/- (Rupees one thousand) only for each vehicle in the form of crossed Demand Draft / Bankers' Cheque drawn in favour of Deputy Secretary, Secretariat Administration (Estt.) Department, Vehicle Cell from any Nationalised Bank which is payable at Guwahati.
- (3) The intending tenderers may inspect the vehicles during office hours on any working day from 11:30 A.M. to 2:30 P.M.
- (4) The successful tenderers will have to lift the vehicle on payment of the full amount / tender value within 3 (three) days from the date of issue of acceptance letter of this tender, failing which the offer will be treated as cancelled and earnest money will be forfeited.
- (5) The earnest money of the unsuccessful tenderers will be refunded.
- (6) The undersigned does not bind himself to accept the highest tender or to assign any reason for acceptance or rejection of any tender.
- (7) The tenderer will have to collect the format for submission of tender from the SAD, Vehicle Cell during office hour.
- (8) The vehicle should be lifted "As is where is basis / condition".
- (9) The tenderers will have to submit photocopy of Identity Proof and Address Proof (PAN Card / AADHAAR Card / Voter ID card) along with their tenders.
- (10) Preference will be given to the tenderer who bid for entire fleet of vehicles above the depreciated value fixed by the government.  
If there are more than 1 (one) tenderer for entire vehicles, the highest total sum bid value for the entire vehicles will be considered as the successful bidder.
