- (3) The intending tenderers may inspect the vehicles during office hours on any working day from 11:30 A.M. to 2:30 P.M.
- (4) The successful tenderers will have to lift the vehicle on payment of the full amount / tender value within 3 (three) days from the date of issue of acceptance letter of this tender, failing which the offer will be treated as cancelled and earnest money will be forfeited.
