Order

Whereas in view of the spread of novel Corona Virus (COVID-19) in the country and the lockdown imposed by several states; and

Whereas due to the declaration of lockdown in many States/cities particularly New Delhi, Mumbai,, Kolkata, Chennai etc., it is reported that several citizens of Assam have remained stranded.

Therefore, to assist the stranded citizens of the State of Assam in this crisis situation, the following instructions are issued in public interest:

1. The Principal Resident Commissioner, Assam Bhawan, New Delhi, Trade Adviser and Director of Movements, Kolkata/ Salt Lake, Joint Resident Commissioner, Assam Bhawan, Chennai, Mumbai and OSD, Assam House, Shillong are requested to assist the stranded citizens of Assam in the cities which are under lock-down by providing accommodation and fooding as and when approached for such assistance by such citizens.
2. The respective Head of the Houses/Bhawans shall take care to provide necessary assistance in terms of transportation of the stranded citizens of the State as and when such need arises.
3. The respective Head of the Houses/Bhawans are requested to notify a Nodal Officer with designation and contact number in their respective Houses/Bhawans to do the necessary coordination to assist such stranded citizens.
4. The requisite fund on the expenditure to be incurred will be sanctioned by the CEO, ASDMA.
5. Sri G. D. Laskar, ACS (Mob. No. 9435142537), Secretary to the Govt. of Assam and State Protocol Officer, General Administration Department, will be the Nodal Officer from General Administration Department to liaise with the respective Houses/Bhawans.

This order shall come into force with immediate effect.


