First and foremost, I on behalf of Government of Assam would like to express my gratitude to Government of Karnataka for extending all possible help to the people of Assam stranded in various parts of Karnataka.

Further, with reference to the letter cited above, I would like to inform you that a group of 339 persons (including families) from Assam are presently stranded at Bommasandra Jigani Industrial Area, Jigani, Kalubalu Village, Miconagaraj Colony, Bangalore-560105. It is learnt that they are private sector employees, currently jobless and some of them had been there for treatment. Owing to the lockdown and restriction of movement thereby, they are having an acute shortage of food supply. It is my humble request to kindly inform the authorities concerned to coordinate with these stranded people of Assam and provide necessary assistance at this present crisis situation. The details of the stranded persons are enclosed herewith.
