The 1st State Level Coordination Committee meeting for Census-2021 was presided over by Shri Alok Kumar, IAS, Chief Secretary, Assam.

Shri Vivek Joshi, IAS, Registrar General of India and Census Commissioner also participated in the meeting through Video Conference.

At the very outset, the Chief Secretary, Assam welcomed all the members present in the meeting and requested the Director, Directorate of Census Operations, Assam to initiate discussion on the Agenda points.

Shri Narayan Konwar, IAS, Director, Directorate of Census Operations, Assam at first presented powerpoint presentation reflecting all points for Census-2020-21.

After threadbare discussion on the agenda points, following decisions were made-

1. The Registrar General and Census Commissioner, India proposed to Constitute a District Level Coordination Committee for Census- 2021 along the lines of State Level Coordination Committee in all the districts, for which the Director, Directorate of Census Operations, Assam may be requested to submit the proposal. **Action : Directorate of Census Operations, Assam**
2. The Chief Secretary, Assam directed the Joint Secretary, Urban Development Department to look into the matter of inclusion of Revenue Villages (part/ full to be specified) which are not clear in present Notification and to do the needful to renotify the same with necessary correction if required. **Action : Urban Development Department.**
3. The Registrar General and Census Commissioner, India requested to fix the schedule of enumeration for Houselisting Blocks in consultation with Directorate of Census Operations, Assam in reference to the RGI letter D.O. No. 9/43/2019-CD(Cen), 7/10/2019. **Action : General Administration Department and Directorate of Census Operations, Assam**
4. The Registrar General and Census Commissioner, India requested the Chief Secretary for holding State Level Coordination Committee meeting for Census- 2021 monthly. **Action : General Administration Department.**
5. To request the concerned Deputy Commissioners viz., Sivasagar, Golaghat, Dima-Hasao and Kamrup for submitting the pending utilization certificate of census 2011 and NPR without further delay, within 22/11/2019. **Action: General Administration Department.**
