The Officers named in Annexure I and Annexure II are also hereby authorised to issue declaration in writing reffered to in Sub-Section (3) of Section 4 in respect of all Census Officers appointed by them.

In exercise of the powers conferred by Sub-Section (4) of the said Act, the Governor of Assam is pleased to delegate the power of appointing Census Officers within the jurisdiction to the Officers mentioned in Annexure I and Annexure II above.

As per the provisions of <u>Section 11 of the Census Act 1948</u>, any Census -Officer or any other person lawfully required to give assistance towards the taking of Census and who refuses to perform any duty allotted to him/ her under this Act or any rule made thereunder, or any person who hinders or obstructs another person in performing any such duty, shall be punishable with fine up to one thousand rupees and in case of a conviction shall also be punishable with imprisonment which may extend to three years.
