Guidelines for repairing/renovation etc., of Govt. Residential Ouarter.

As per minutes of the meeting held on 21/09/2018 at 1100 hrs in order to streamline the process for repairing/renovation etc. of Govt. Residential Quarter under GAD, the following guidelines are to be adopted for repairing / renovation works :

1. No structural change / extension of the Building shall be executed without prior approval of GAD.

- 2. Major repairing works should not be undertaken in Quarters which are already marked for demolition.
- 3. Quarters which have not been repaired within the last three years shall be given priority.
- 4. In case of Officers Quarter, the details of the repairing works undertaken within the last three years should be considered.
- 5. Outside painting of the buildings have to be kept uniform.
- 6. No major electrical repairing required in case an Officer has been continously residing in the same Quarter.
- 7. Electrical repairing/renovation has to be considered whenever a Quarter is alloted afresh to a Officer/Staff.
- 8. Additional Installation of A.C. / Geyser will not be entertained without prior approval of GAD.
- For re-wiring/ renovation of Internal/ External electrification at Sr. Officers Colony Khanapara. 9. estimated amount will be Rs. 7,00,000 /- (excluding AC & Geyser)
