## ORDER

<u>No.S(E)2/2022/5</u>: Whereas Smti. Sima Devi, Sr.A.A. of Welfare of Bodoland Department, Janata Bhawan was arrested by the officials of Directorate of Vigilance and Anti-Corruption, Assam, Srimantapur, Guwahati-781032 on 04-01-2022 at 1:05 P.M. in connection with ACB PS Case No.01/2022 U/S 7(a)/13(2)PC Act, 1988 (as amended, 2018) and was detained under custody beyond 48 hours.

Therefore in exercise of powers conferred under Rule-6(2) of the Assam Services (Discipline & Appeal) Rules, 1964, Smti. Sima Devi, Sr.A.A. of Welfare of Bodoland Department, Janata Bhawan is hereby deemed to have been placed under suspension with effect from the date of her arrest i.e. 04-01-2022 until further orders.

During the period of suspension the headquarter of Smti. Sima Devi, Sr.A.A., if released from judicial custody, will be Guwahati subject to review if deemed necessary.

Henceforth, it is not permissible for her without previous sanction of the undersigned to accept private employment or business while under suspension.
